Bid prices shall remain firm for a period of sixty (60) days.

All bids must be submitted on the Proposal Forms furnished by the Township. Each Proposal must be enclosed in a **SEALED ENVELOPE**, properly endorsed with the name of the Bidder, with the designation "**TOWNSHIP OF RANDOLPH, SEALED BID, PURCHASE OF ONE (1) NEW, UNUSED 2016 OR NEWER F-550 OR EQUIVALENT 3-4 YARD DUMP TRUCK, SEPTEMBER 9, 2016, 11:00 A.M.**" **Any envelope that is received that is not properly marked causing it to be opened prior to the bid will be invalidated.** Bids may be received before the hour designated in this office, if they are mailed or hand delivered in person. The Township of Randolph will not be responsible for any bid that is sent by mail or other form of carrier which is lost or which arrives after the bid date and time.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq. Bidders must comply with the requirements of P.L. 1977, Chapter 33, requiring stockholders' and partnership names.
