NOTICE IS HEREBY GIVEN that sealed bids will be received by the Purchasing Agent, Township of Randolph in the Municipal Courtroom, 502 Millbrook Avenue, Randolph, NJ, on **WEDNESDAY, OCTOBER 13, 2021, 11:00 A.M.** prevailing time, and at that time will be publicly opened and read for **LEASE OF PUBLIC PROPERTY DESCRIBED AS A PORTION OF TAX BLOCK 195 LOT 18 AT 80 ROUTE 10 WEST, RANDOLPH, NJ FOR PURPOSES OF ERECTING BILLBOARDS FOR COMMERCIAL ADVERTISING.** Bid prices shall remain firm for a period not later than the second regular meeting of the governing body following completion of the bidding, unless adjourned at the time advertised for such meeting for not more than one week without notice in accordance with N.J.S.A. 40A:12-14.

All bids must be submitted on the Proposal Forms furnished by the Township. Bids shall be addressed to the Purchasing Agent, Purchasing Office, Township of Randolph, 502 Millbrook Avenue, Randolph, NJ 07869. Each Proposal must be enclosed in a **SEALED ENVELOPE**, properly endorsed with the name of the Bidder, with the designation "**TOWNSHIP OF RANDOLPH, SEALED BID, LEASE OF PUBLIC PROPERTY DESCRIBED AS A PORTION OF TAX BLOCK 195 LOT 18 AT 80 ROUTE 10 WEST, RANDOLPH, NJ FOR PURPOSES OF ERECTING BILLBOARDS FOR COMMERCIAL ADVERTISING, OCTOBER 13, 2021, 11:00 A.M.**" **Any envelope that is received that is not properly marked causing it to be opened prior to the bid will be invalidated.**

Bids must be accompanied by a Certified Check, Cashier's Check or Bid Bond payable to the Township of Randolph in the amount of \$2,000 and a duly executed Consent of Surety and Power of Attorney on the standard New Jersey Statutory bond form, as set forth in the Bid Specifications, issued by a surety company licensed to do business in the State of New Jersey. Bid will require a Performance Bond in the amount of \$20,000.

The Township reserves the right to reject any or all bids, or any part thereof, waive informalities therein and to award the bid in the best interest of the Township.
